DIDYOU KNOW

- 1956 For the first time, a Never Out list was published, a correspondence course in retail store management was developed, a merchandise calendar was distributed and training films and booklets were produced.
- 1967 Project ATOMIC was introduced in larger commissary store complexes. The purpose of the project was to automate procurement, inventory control and accounting functions through the use of a Robot XI desk-size computer.
- 1969 Ground breaking for the new Norfolk, VA Navy Exchange occurred as did the establishment of the San Diego Navy Exchange Service Center (NESC).
- 1973 NRSO entered the fast-food field with the creation of Chick-Inns at five U.S. locations.
- 1976 NRSO was granted authority over the selection of key management positions in the field. The Secretary of the Navy approved central office selection and funding for the transfer of personnel October 1.
- 1985 Men's clothes were added to the Harbor View label, after ladies slacks were introduced to the Harbor View label in 1985.
- 1987 The House Armed Services Committee abolished the price ceiling for ready-to-assemble furniture.
- 1989 The Carlson Award was established to recognize Navy Lodge excellence. The award was named after Edward E. Carlson who served as distinguished member of the Navy Resale System Advisory Committee for 24 years.
- 1992 The first and only NEX Club was located in Alameda, CA. This NEX Club was based on a warehouse concept and offered a no-frills shopping experience. Originally opened as a test site, the NEX Club closed in August 1995.

- 1994 NEX Great Lakes prerecorded music superstore had its grand opening on the 28th of December.
- 1996 The Navy Exchange Service Command celebrates its 50th anniversary on the 1st of April.
- 2004 The NEREA Scholarship Fund awarded fourteen (14) \$2000 scholarships.
- 2010 Navy Lodge North Island opens a new 146,000 sq. ft, 4-story, 205 - room Lodge that replaced the original 90 room Lodge built in 1969.
- 2014 NEX launched the private label snack North Star Trading Company program, which features a selection of nuts and nut blends.
- 2016 The first electric vehicle (EV) charger within the Department of Defense is installed at NEXCOM Headquarters in Virginia Beach.
- 2018 In the aftermath of Hurricane Michael NEXCOM sent a Mobile Retail Facility (MRF) to NSA Panama City FI. to help in the clean up effort. The NEX MRF was stocked with basic health and comfort items as well as food and cold drinks.
- 2020 NEXCOM's Ships Store Program launched the first Micro Market@Sea concept in November. Worldwide, there were 77 Micro Market ashore operations, located in Navy hospitals, aircraft hangers, office spaces and shipyards.
- 2022 The overseas Student Meal Program served more than 925,000 meals to military children at 20 Department of Defense Education Activity schools in Europe, Japan, Guam and Guantanamo Bay Cuba.

BOARD VOTED TO SUPPORT AAFES'S POSITION IN THE CAC CARD ISSUE

Dear Members,

AREA is not satisfied with the pace of standardized installation access for retired DoD Civilians. Working with Exchange leadership, AREA has communicated its concerns regarding retiree access with OSD, Army and Air Force stakeholders. While this impacts all DoD Civilian retirees, AAFES retirees are uniquely impacted due to our shopping privileges. While the deadline for full implementation is not until May 2025, AREA does not believe the current situation is acceptable and is impacting one of our cherished retirement benefits. AREA is encouraging our members and other retirees to contact their representatives asking them to act in support of all DoD Civilian retirees. AREA is in contact with the Navy Exchange Retired Employees Association (NEREA) President who concurs with our call to action. NEREA has indicated they will participate with AREA on this issue.

To expedite this effort, AREA is providing relevant talking points to assist in developing communications with representatives. We have decided that this is better than providing a standard letter, which may be ignored if seen as a form letter. AREA recommends using bullet points and brevity to increase chances of the letters/ emails being read. Be sure to point out Exchange retirees dedicated most of their lives not only to the Exchange systems and their mission to support the military, but to an individual commitment to the US military to serve in the US and Globally. Many have proven this through voluntary deployment to areas of conflict. Contact information for Senators and Representatives (contact with Governors especially in states with a high Military and Retiree populations). This link provides contact information by mail, phone and most have a Contact Us Tab on their sites. This link also has contact information for state officials.

AREA's Goal

- AREA would like to see the intent of the REAL ID Act fully implemented across DoD. (Ideally before the questionable May 2025 implementation deadline)
- Utilizing a scannable REAL ID i.e. Driver's License for common access to all installations unless access is determined by mission/security concerns.
- A Standard that the REAL ID would be accepted for access until that ID expired in which case access would be renewed when the ID is renewed unless for reasons of change of status of the ID holder or failure to pass a background check.
- Portability of that ID across installations unless access is restricted due to mission/security concerns.
- Include escort privileges for immediate family members. Would like to see spouses IDs included in DBIDS.

Impact

- The Exchanges provide a significant impact for MWR facilities, providing millions in dividends each year to support critical military Quality-of-Life programs. Sales determine the amount that is provided each year.
- Retirees of the Exchange systems earned the shopping benefit through a dedication to the Exchange and contribute significantly to the overall sales of the Exchange systems.
- The Exchanges provide significant employment opportunities for military spouses and veterans. The Army & Air Force Exchange Service has earned numerous awards for their employment of military spouses and veterans. For this to continue, the viability of the Exchange systems must be maintained. This means every effort must be made to maintain and build on shopping privileges to increase sales.

- Use of installation MWR facilities provides additional funds. If a retiree has a problem accessing the installation, those funds are lost.
- The change in stopping the use of the retiree CAC has impacted ALL DoD civilian retirees, not just those that retired from an Exchange system.

AREA hopes that most of you utilize the guidance and contact your elected officials. Please keep all communications professional and respectful. We are asking for their assistance and support. Remember only 18% of our Representatives / Senators have had military service so their understanding of the culture and organizations involved may be limited. Refrain from using acronyms, do not have expectations that they will initially understand who AAFES is or what we do. Many of you may no longer visit installations so feel that it does not apply to you, but it does. Our Pension and benefits are dependent on the health of the Exchange. The shopping benefit is important to your fellow retirees, help support them.

In 2002, NEXCOM began offering CNA Long Term Care Insurance (LTC) to associates and retirees. In 2016, CNA closed the Plan to new enrollees. The LTC landscape vastly changed and companies offering group LTC Plans began to exit the market.

CNA recently began notifying all NEXCOM associates and retirees enrolled in their plans about upcoming premium increases that have been approved by the state or Commonwealth. These increases will be implemented over multiple years and will vary based on the specific product and inflation features of each plan.
